- Brief History of CSLF Recognized Projects
 - 65 Projects recognized from 2004-2018
 - 23 Complete (35%)
 - 30 Active or Near Completion (46%)
 - 12 Discontinued or Ended without Completion (18%)



Reinforce

- Introduce Criteria Categories
 - Stage of Completion
 - Region
 - Scale
 - Technology
 - Technology Readiness Level (TRL)
 - Commercial Contribution
 - Unique Characteristics
- Align CSLF recognized projects to CSLF Technology Roadmap

PIRT Submission Form

- Project Description and Relevance:
 - How is your project adding to the global body of CCUS knowledge? What do you anticipate learning from this project?
 - How is this project leading toward commercialization of CCUS?
- Project Description (Technical)
 - What stage is this project at? [prefer FEED or later]
 - What TRL is this project demonstrating?

PIRT Submission Form

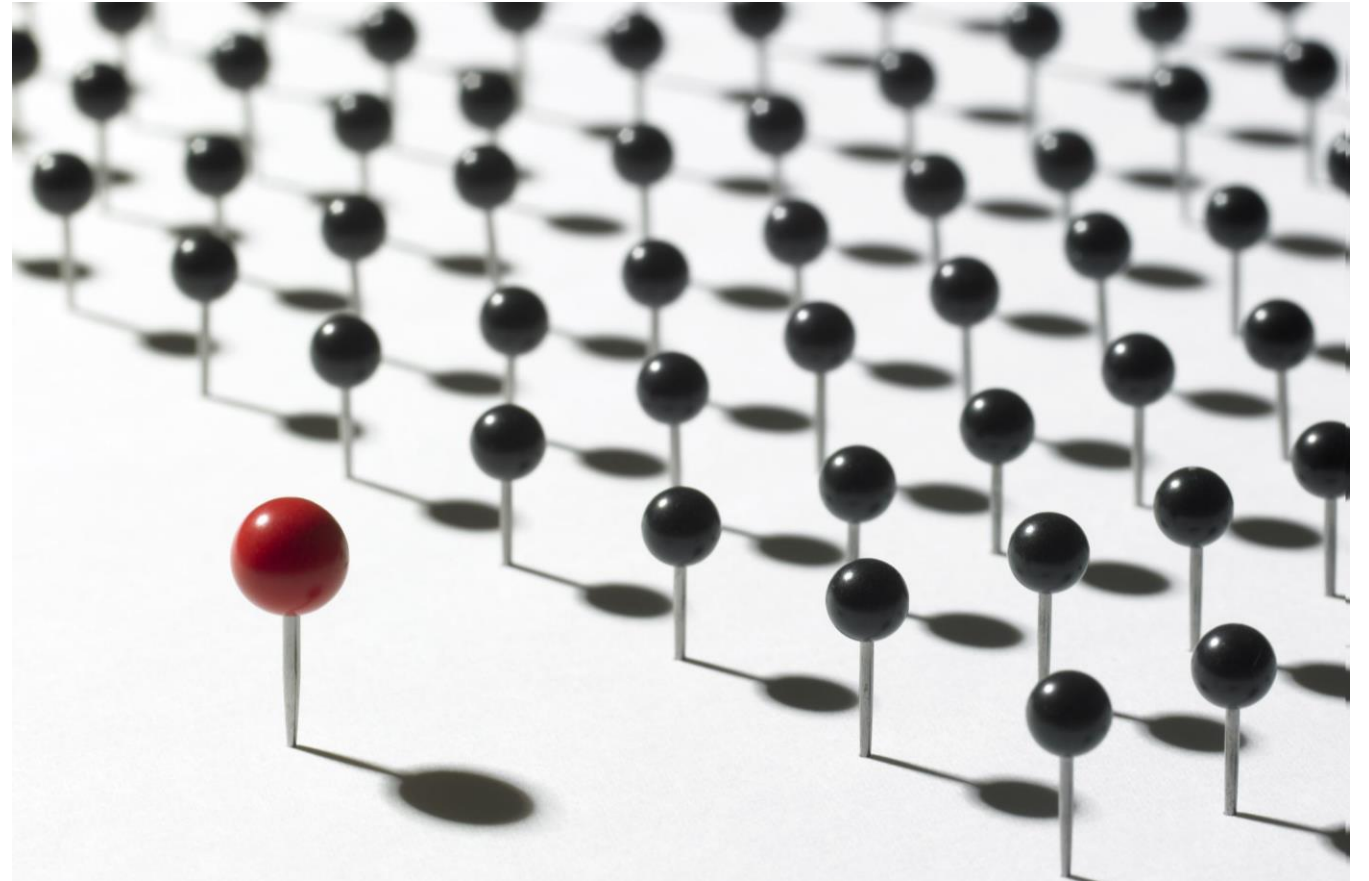
- Novel Aspects of Project
 - What, if any, new or novel project aspects are you anticipating in the policy, legal, or regulatory arenas?
 - What, if any, new or novel project financing mechanisms or business models are you engaging?
 - What technological contribution is this project making?



Re-invigorate

- Actively manage recognition process by inviting projects AND self-nomination
- Encourage all CSLF members to recommend and propose projects for recognition
- Targeted approach to project recognition, align with CSLF Technology Roadmap

Next Steps

- Review existing list of projects
- Revise On-boarding/Application process ✓
 - **Proactively approach projects and invite to join/seek recognition from CSLF**
 - Simplify application process, and use to engage projects more fully and set expectations for participation
 - **Projects present at PIRT section of CSLF meeting and use guidelines for what to present, technical details of project, how integrate into CSLF, what hoping to gain from participation...** ✓
- **Establish project review form for members to use during PIRT presentations, collect input, formulate some standard questions**
- **Establish an Exit Interview strategy – to interview and gain insights into learnings, pit falls, successes, even if projects do not go to completion, collect learnings as we go**
