ORDER GRANTING LONG-TERM AUTHORIZATION
TO IMPORT NATURAL GAS FROM CANADA

DOE/FE ORDER NO. 995

OCTOBER 27, 1994

I. DESCRIPTION OF REQUEST

On September 27, 1994, Westcoast Gas Services Inc. (Westcoast) filed an application with the Office of Fossil Energy of the Department of Energy (DOE), under section 3 of the Natural Gas Act (NGA)1/, and DOE Delegation Order Nos. 0204-111 and 0204-127, requesting authorization to import natural gas from Canada. The authorization would allow Westcoast to import at Monchy, Saskatchewan, up to 1,072 Mcf per day of gas over a period of nine years through November 1, 2003. Westcoast, a Canadian corporation with its principal office in Calgary, Alberta, is a marketer of natural gas throughout North America. Westcoast will purchase this imported gas from several Canadian producers and sell it to Interstate Power Company Inc. (Interstate). Interstate is a local gas distribution company which serves customers in Iowa. The gas would be imported into the United States through the pipeline facilities of Northern Border Pipeline Company.

Westcoast and Interstate entered into a letter agreement dated June 3, 1994, which essentially contains the terms and conditions that will later be included in a formal sales contract between Westcoast and Interstate governing the import of the gas. The period of their import arrangement will be from the first date of deliveries on November 1, 1994, through November 1, 1999, and may be further extended through November 1, 2003. The agreement provides for a market-based commodity price which will

be determined monthly from an index of spot market prices of gas delivered to four interstate pipeline systems in Texas, Oklahoma, and Kansas as published in Inside FERC's Gas Market Report. The

pipeline companies comprising the index are Northern Natural Gas Company, Natural Gas Pipeline Company, Panhandle Eastern Pipe Line Company, and ANR Pipeline Company. The price each month would contain: (1) a commodity charge; (2) the demand charges covering the demand tolls for transportation in Canada on the pipeline systems of NOVA Corporation of Alberta (NOVA) and Foothills Pipelines Ltd. (Foothills); and (3) a variable charge equal to the commodity charges for transportation and fuel gas used on the systems of NOVA and Foothills. The commodity charge per MMBtu²/ sold to Interstate will be equal to 86.5 percent of the arithmetic average of the index prices.

Additionally, Interstate may have to pay Westcoast a deficiency charge if Interstate purchases less than 90 percent of the sum of the maximum daily contract quantities (1,072 Mcf) each year. The deficiency charge per Mcf would be equal to 25 percent of the weighted average of the monthly commodity prices during that year, multiplied by the shortfall.

II. FINDING ---

The application filed by Westcoast has been evaluated to determine if the proposed import arrangement meets the public interest requirements of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under section 3(c), the importation of natural gas from a nation

with which there is in effect a free trade agreement requiring national treatment for trade in natural gas is deemed to be consistent with the public interest and must be granted without modification or delay. The authorization sought by Westcoast to import natural gas from Canada, a nation with which a free trade agreement is in effect, meets the section 3(c) criterion and, therefore, is consistent with the public interest.

ORDER

Pursuant to section 3 of the Natural Gas Act, it is ordered that:

A. Westcoast Gas Services Inc. (Westcoast) is authorized to import up to 1,072 Mcf per day of natural gas from Canada for sale to Interstate Power Company Inc. (Interstate). Westcoast shall import this gas near Monchy, Saskatchewan, pursuant to the terms of the letter agreement between Westcoast and Interstate dated June 3, 1994, filed in this proceeding.

B. The term of this import authorization shall extend from November 1, 1994, through November 1, 2003.

C. Westcoast shall file with the Office of Fuels Programs (OFP), Fossil Energy, Room 3F-056, Forrestal Building, 1000 Independence Avenue, S.W., Washington, D.C. 20585, the formal gas sales contract between Westcoast and Interstate, within 15 days of its execution.

D. Within two weeks after deliveries begin, Westcoast shall notify OFP in writing of the date that the first import of natural gas authorized in Ordering Paragraph A above occurred.

E. With respect to the natural gas imports authorized by this Order, Westcoast shall file with OFP, within 30 days following each calendar quarter, quarterly reports showing by month the total volume (in Mcf) imported and the average purchase price per MMBtu paid at the international border. The price information for a particular month shall list separately (on a per unit [MMBtu] basis) the gas commodity charge, the Canadian pipeline demand charges, and the Canadian pipeline variable charges. The reports shall also itemize separately any minimum take deficiency payments made by Interstate during a particular calendar quarter.

F. The first quarterly report required by Ordering Paragraph E is due not later than January 30, 1995, and should cover the period from November 1, 1994, until the end of the fourth calendar quarter, December 31, 1994.
