ORDER GRANTING BLANKET AUTHORIZATION  
TO IMPORT AND EXPORT NATURAL GAS FROM AND TO MEXICO

I. DESCRIPTION OF REQUEST \_\_\_\_\_

On July 12, 1996, Producers Energy Marketing, LLC (ProEnergy) filed an application with the Office of Fossil Energy of the Department of Energy (DOE), under section 3 of the Natural Gas Act (NGA)<sup>1/</sup> and DOE Delegation Order Nos. 0204-111 and

0204-127, for blanket authorization to import and export from and to Mexico up to a combined total of 365 Bcf of natural gas over a two-year term beginning on the date of initial import or export delivery. ProEnergy, a marketer of natural gas, is a Delaware limited liability company with its principal place of business in Houston, Texas. ProEnergy states that the terms of any import or export arrangement will be competitive with market conditions and that it will act on its own behalf as well as on behalf of others. ProEnergy requests authority to import or export natural gas at any point on the international border where transportation facilities currently exist.

II. FINDING \_\_\_\_\_

The application filed by ProEnergy has been evaluated to determine if the proposed import/export arrangement meets the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under section 3(c), the import or export of natural gas from or to a nation with which there is in effect a free trade agreement requiring national treatment for trade in natural gas is deemed to be consistent with the public interest and must be granted without modification or delay. The authorization

sought by ProEnergy to import and export natural gas from and to Mexico, a nation with which a free trade agreement is in effect, meets the section 3(c) criterion and, therefore, is consistent with the public interest. This blanket order authorizes transactions under contracts with terms of no longer than two years.

ORDER

Pursuant to section 3 of the Natural Gas Act, it is ordered that:

A. Producers Energy Marketing, LLC (ProEnergy) is authorized to import and export up to a combined total of 365 Bcf of natural gas from and to Mexico over a two-year term beginning on the date of first import or export delivery. This natural gas may be imported and exported at any point on the U.S./Mexico border.

B. Within two weeks after deliveries begin, ProEnergy shall provide written notification to the Office of Fuels Programs (OFP), Fossil Energy, Room 3F-056, FE-50, Forrestal Building, 1000 Independence Avenue, S.W., Washington, D.C. 20585, of the date that the first import or export delivery of natural gas authorized in Ordering Paragraph A above occurred.

C. With respect to the natural gas imports and exports authorized by this Order, ProEnergy shall file with OFP, within 30 days following each calendar quarter, quarterly reports indicating whether imports or exports of natural gas have been made. Quarterly reports must be filed whether or not initial

deliveries have begun. If no imports or exports of natural gas have been made, a report of "no activity" for that calendar quarter must be filed. If imports or exports have occurred, ProEnergy must report the following: (1) total monthly volumes in Mcf; (2) the average monthly purchase price of gas per MMBtu at the international border; (3) the name of the seller(s); (4) the name of the purchaser(s); (5) the estimated or actual duration of the agreement(s); (6) the name of the United States transporter(s); (7) the point(s) of entry and exit; and (8) the geographic market(s) served (for imports, by State). For import transactions only, the report shall also include: (1) whether sales are being made on an interruptible or firm basis; and, if applicable, (2) the per unit (MMBtu) demand/commodity/reservation charge breakdown of the contract price.

D. The first quarterly report required by Ordering Paragraph C of this Order is due not later than October 30, 1996, and should cover the period from the date of this Order until the end of the third calendar quarter, September 30, 1996.
