ORDER GRANTING BLANKET AUTHORIZATION TO
IMPORT NATURAL GAS FROM CANADA

DOE/FE ORDER NO. 1758

MARCH 12, 2002

I. DESCRIPTION OF REQUEST

On March 8, 2002, Burlington Resources Canada Marketing Ltd. (Burlington) filed an application with the Office of Fossil Energy of the Department of Energy (DOE), under section 3 of the Natural Gas Act (NGA)^{1/} and DOE Delegation Order Nos. 0204-111 and 204-127, for authorization to import from Canada up to 250 Bcf of natural gas over a two-year term, beginning on March 31, 2002.^{2/} Burlington, a Delaware corporation with its principal place of business in Calgary, Alberta, Canada, is involved in the exploration, production and marketing of oil, natural gas and petroleum products. Burlington is the wholly-owned subsidiary of Burlington Resources Canada Ltd., a subsidiary of Burlington Resources, Inc. Burlington will import the natural gas under spot and short-term purchase arrangements for sale to customers in the United States. The proposed authorization does not involve the construction of new pipeline facilities.

II. FINDING

The application filed by Burlington has been evaluated to determine if the proposed import arrangement meets the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under section 3(c), the import of natural gas from a nation with which there is in effect a free trade agreement requiring national treatment for trade in natural gas is deemed to be consistent with the public interest and must be granted without modification or delay. The authorization sought by Burlington to import natural gas from Canada, a nation with which a free trade agreement is in effect, meets the section 3(c) criterion and, therefore, is consistent with the public interest. This blanket Order authorizes transactions under contracts with terms of no longer than two years.

ORDER

Pursuant to section 3 of the Natural Gas Act, it is ordered that:

A. Burlington Resources Canada Marketing Ltd. (Burlington) is authorized to import from Canada up to 250 Bcf of natural gas over a two-year term, beginning on March 31, 2002, and extending through March 30, 2004.

B. This natural gas may be imported at any point on the border of the United States and Canada.

C. With respect to the natural gas imports authorized by this Order, Burlington shall file with the Office of Natural Gas & Petroleum Import & Export Activities, within 30 days following each calendar quarter, reports indicating whether imports of natural gas have been made. If no imports of natural gas have been made, a report of "no activity" for that calendar quarter must be filed. If imports have occurred, Burlington must report total monthly volumes in Mcf and the average purchase price of gas per MMBtu at the international border. The reports shall also provide the details of each transaction, including: (1) the name of the seller(s); (2) the name of the purchaser(s); (3) the estimate or actual duration of the agreement(s); (4) the name of the U.S. transporter(s); (5) the point(s) of entry; (6) the geographic market(s) served; (7) whether sales are being made on an interruptible or firm basis; and, if applicable (8) the per unit (MMBtu) demand/commodity/reservation charge breakdown of the contract price. D. The first quarterly report required by Ordering Paragraph C of this Order is due not later than July 31, 2002, and should cover the period from April 1, 2002, until the end of the second calendar quarter, June 30, 2002.

E. The quarterly reports required by Ordering Paragraph C of this Order shall be filed with the Office of Natural Gas & Petroleum Import & Export Activities, Fossil Energy, Room 3E-042, FE-34, Forrestal Building, 1000 Independence Avenue, S.W., Washington, D.C. 20585.
