ORDER VACATING BLANKET AUTHORIZATION

DOE/FE ORDER NO. 1241- A

In DOE/FE Order No. 1241<sup>1</sup> (Order 1241) issued in FE Docket No. 97-09 on January 28, 1997, the Office of Fossil Energy (FE) of the Department of Energy (DOE) granted blanket authorization to USGen Fuel Services, Inc. (USGen Fuel) to import and export natural gas from and to Canada. On February 2, 2005, US Gen Fuel notified DOE that it did not intend to use its authorization and requested that DOE to vacate Order 1241.

Accordingly, pursuant to section 3 of the Natural Gas Act, the authorization granted to US Gen Fuel by Order 1241 is hereby vacated.
