# ORDER VACATING BLANKET AUTHORIZATION

### DOE/FE ORDER NO. 1903-A

In DOE/FE Order No. 1903<sup>⊥</sup> (Order 1903) issued in FE Docket No. 03-59-NG on October 8, 2003, the Office of Fossil Energy (FE) of the Department of Energy (DOE) granted blanket authorization to FUSI LLC (FUSI) to import and export natural gas from and to Canada. On January 19, 2005, FUSI requested DOE to vacate Order 1903, effective December 21, 2004.

Accordingly, pursuant to section 3 of the Natural Gas Act, the blanket authorization granted by DOE/FE Order No. 1903, is hereby vacated, effective December 21, 2004.

With this letter I am transmitting the application of Fortuna (US) L.P. for a twoyear blanket authorization to import and export natural gas under Section 3 of the Natural Gas Act.

I am also by this letter advising you that, as of the date upon which Fortuna (US) L.P. is granted its authorization, the blanket authorization to import gas from and to Canada which FUSI LLC presently holds in Docket No. **FE03-59-NG** would be vacated.

On October 8, 2003, the Department of Energy, Office of Fossil Energy (FE) issued Order No. 1903 in Docket No. FE03-59-NG, which granted FUSI LLC blanket authorization to import and export natural gas from and to Canada. This letter is filed pursuant to 10 C.F.R. § 590.405 and 590.407 to advise you that FUSI LLC was converted into Fortuna (US) L.P., a Delaware limited partnership. A copy of the Certificate of Conversion to Limited Partnership issued by the Office of Secretary of State of the State of Delaware is attached.

Fortuna (US) L.P. requests that the blanket authorization described above be permitted to become effective retroactively, as of December 21, 2004. As of that same date, the authorization issued to FUSI LLC would be deemed terminated. Reports for the fourth quarter of 2004 would, accordingly, be filed by both entities.
