ORDER VACATING BLANKET AUTHORIZATION
TO IMPORT AND EXPORT NATURAL GAS
FROM AND TO CANADA AND MEXICO

DOE/FE ORDER NO. 2375-A

On June 22, 2007, the Office of Fossil Energy (FE) of the Department of Energy (DOE) granted blanket authorization to TXU Portfolio Management Company LP (TXUPM) in DOE/FE Order No. 2375 (Order 2375) (2FE ¶1,472) to import up to 120 billion cubic feet (Bcf) of natural gas from Canada, and to export up to 120 Bcf of natural gas to Canada over a two-year term beginning on July 27, 2007, and extending through July 26, 2009. TXUPM is also authorized to import up to 120 Bcf of natural gas from Mexico, and to export up to 120 Bcf of natural gas to Mexico over a two-year term beginning on July 27, 2007, and extending through July 26, 2009.

On October 10, 2007, TXUPM requested that DOE vacate Order 2375, effective October 1, 2007. Effective October 1, 2007, TXUPM converted to Luminant Energy Company LLC. TXUPM has requested that the application for an import and export order for Luminant Energy Company be approved and a subsequent order issued, and DOE/FE Order 2375 be vacated.

Accordingly, pursuant to section 3 of the Natural Gas Act, the authorization to import and export natural gas granted to TXUPM in Order 2375 is hereby vacated, effective October 1, 2007.
