ORDER GRANTING BLANKET AUTHORIZATION TO  
IMPORT AND EXPORT NATURAL GAS  
FROM AND TO CANADA

DOE/FE ORDER NO. 2469

FEBRUARY 26, 2008

## I. DESCRIPTION OF REQUEST

On February 13, 2008, Cannat Energy Inc. (Cannat) filed an application with the Office of Fossil Energy (FE) of the Department of Energy (DOE), under section 3 of the Natural Gas Act (NGA),<sup>1</sup> for blanket authorization to import up to 190 billion cubic feet (Bcf) of natural gas from Canada and to export up to 12 Bcf of natural gas to Canada. The applicant requests the authorization be granted for a two-year term beginning on February 29, 2008.<sup>2</sup> Cannat is a Delaware corporation with its principal place of business in Calgary, Alberta.

## II. FINDING

The application has been evaluated to determine if the proposed import and export arrangement meets the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under section 3(c), the import and export of natural gas, including liquefied natural gas (LNG), from and to a nation with which there is in effect a free trade agreement requiring national treatment for trade in natural gas and the import of LNG from other international sources are deemed to be consistent with the public interest and must be granted without modification or delay. The authorization sought by Cannat to import and export natural gas from and to Canada, a nation with which a free trade agreement is in effect, meets the section 3(c) criterion and, therefore, is consistent with the public interest. This Order authorizes transactions with terms of no longer than two years.

<sup>2/</sup> Cannat's blanket authorization to import natural gas from Canada granted in DOE/FE Order No. 2276 on October 27, 2006, extends through November 30, 2008 (2 FE ¶ 71,347). Cannat has requested new blanket authority that will include both the import and export of natural gas from and to Canada. As a result, Cannat has requested that its current authorization (Order 2276) be vacated and replaced with this new authorization, to be effective February 29, 2008.

ORDER

Pursuant to section 3 of the NGA, it is ordered that:

A. Cannat is authorized to import up to 190 Bcf of natural gas from Canada and to export up to 12 Bcf of natural gas to Canada, pursuant to transactions that have terms of no longer than two years. This authorization shall be effective for a two-year term beginning on February 29, 2008 and extending through February 28, 2010.

B. This natural gas may be imported and exported at any point on the border between the United States and Canada.

C. **Monthly Reports:** With respect to the natural gas imports and exports authorized by this Order, Cannat shall file a report with the Office of Natural Gas Regulatory Activities within 30 days following the last day of each calendar month indicating whether imports and/or exports of natural gas have been made. Monthly reports must be filed whether or not initial deliveries have begun. If imports and/or exports have not occurred, a report of “no activity” for that month must be filed. If imports and/or exports of natural gas have occurred, the report must give the following details: (1) for imports, the country of origin; (2) for exports, the country of destination; (3) the point(s) of entry and exit; (4) the volume in thousand cubic feet (Mcf); (5) the average purchase price of gas per million British thermal units (MMBtu) at the international border; (6) the name of the supplier(s); (7) the name of the U.S. transporter(s); (8) the estimated or actual duration of the supply agreement(s); and (9) for imports, the geographic market(s) served (list State(s), U.S. Census Region(s), or general U.S. geographic area(s)). D. The first monthly report required by this Order is due not later than March 30, 2008, and should cover activity occurring on February 29, 2008.
