MOTION TO INTERVENE OF SHELL US GAS & POWER LLC

Pursuant to 10 C.F.R. § 590.303 (2010), Shell US Gas & Power LLC (“Shell”)

hereby moves to intervene in the above-captioned proceeding. In support of its motion, Shell states as follows:

On September 7, 2010, Sabine Pass Liquefaction, LLC (“Sabine Pass”) filed an “Application For Long-Term Authorization To Export Liquefied Natural Gas” (“Application”), wherein, it requested authority to export up to 16 mtpa of domestically produced liquefied natural gas (“LNG”) from the Sabine Pass LNG Terminal to any country (1) with which the United States does not have a free-trade agreement, (2) which has the capacity to import LNG, and (3) with which trade is not prohibited by law or policy of the United States. Sabine Pass requested authorization for a twenty-


year term, commencing on the earlier of the date of first export, or five years from the date of an order granting the Application.

Given that the Application is requesting broad authority to export LNG from the United States to nearly all other countries, worldwide, Shell has a direct interest in this proceeding. Shell, through its affiliates, is a major holder of LNG import capacity rights at U.S. LNG terminals. Further, Shell, through its affiliates, is a major producer of natural gas in the United States. The Application, if granted, could affect Shell's interest as an LNG importer and as a domestic natural gas producer due to the potential impacts on the markets for LNG and domestically produced natural gas. Thus, Shell has a substantial interest in, and will be directly affected by, the outcome of this proceeding. Further, no other party can adequately represent Shell's interests. Shell requests that it be permitted to intervene in this proceeding, and that it be granted full rights as a party to this proceeding.

Shell is continuing to study the Application and, as a result, is unable to state a position on the Application at this time.

WHEREFORE, Shell respectfully requests that its motion to intervene be granted.

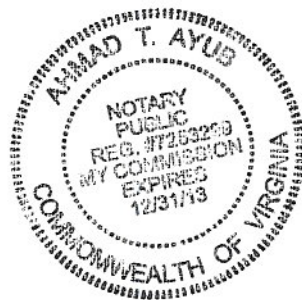
