Dear Mr. Anderson:

CE FLNG, LLC ("CE FLNG") has filed an application for long-term export authorizations under U.S. Department of Energy ("DOE") Office of Fossil Energy ("DOE/FE") Docket No. 12-123-LNG. In Docket No. 12-123-LNG, DOE/FE issued Order No. 3193. As requested in the application, this order conditionally authorizes the export of domestic LNG to countries with which the United States has a Free Trade Agreement ("FTA") calling for the national treatment of natural gas. (The application also requests authorization to export domestic LNG to non-FTA countries and that application is still awaiting a decision by DOE/FE.)

In DOE/FE Order No. 3193, CE FLNG was directed to file under seal long-term contracts for its liquefaction export services. CE FLNG was also required to register with DOE/FE any customer for whom it would act as agent for LNG exports.

In full compliance with DOE Order 3193, CE FLNG has filed with DOE/FE both a copy of that long-term contract under seal and the required registration for the customers. CE FLNG hereby files with DOE a form containing summary information from the long-term contract.

Proposed LNG facility to be located in Plaquemines Parish, Louisiana.

3. Describe Affiliation with LNG Liquefaction Export Facility (e.g. owner, capacity holder, etc.):

The contract has been entered into by owner - Cambridge Energy Group Limited (CEGL), a Bermuda Company and the Parent Company of CE FLNG, LLC. CEGL is establishing a commodities group to facilitate LNG Trading & Shipping.

4. Exact Legal Name of Parties/Counterparties to Contract

20 years from the date of commercial operations for the CE FLNG, LLC Liquefaction Facility (expected start date in early 2018).

416,000,000 MMBtus (+/-) 50% of LNG per contract year.

9. Take or Pay (or equivalent) Provisions/Conditions (please describe):

The Purchase and Sale Agreement is a take or pay contract, pursuant to which, in each Contract Year, Seller shall sell, and Buyer shall buy or pay for if not taken (take or pay), 50% (208,000,000 MMBtus) of the annual minimum quantity of LNG required to be tendered to, and taken or paid for if not taken by, Buyer in any given Contract Year.

10. Supplier (title holder) of Natural Gas to Liquefaction Facility (include whether long or short-term supply, or both), if appropriate. If this does not include the Purchase or Sale of Natural Gas, please mark this Section "Not Applicable":

12. Export Destination Restrictions in the Contract:

The contract restricts exports of LNG received by the customer from the CE FLNG Liquefaction Facility to destination countries permitted under (i) the applicable DOE/FE export authorizations and (ii) U.S. law and policy.

13. Resale Provisions:

The contract requires that the customer's direct and indirect sales or transfers of LNG received from the CE FLNG Liquefaction facility be for delivery only to countries permitted under (i) the applicable DOE/FE export authorizations and (ii) U.S. law and policy.

14. Other Major Non-proprietary Provisions, if applicable:
