# ORDER GRANTING BLANKET AUTHORIZATION TO TO IMPORT LIQUEFIED NATURAL GAS FROM CANADA BY TRUCK

DOE/FE ORDER NO. 3287

MAY 23, 2013

## I. DESCRIPTION OF REQUEST

On May 1, 2013, GDF SUEZ Gas NA LLC (GDF SUEZ) filed an application with the Office of Fossil Energy (FE) of the Department of Energy, under section 3 of the Natural Gas Act (NGA)<sup>1</sup> for blanket authorization to import liquefied natural gas (LNG) up to the equivalent of 1 billion cubic feet (Bcf) of natural gas from Canada by truck. The applicant requests the authorization be granted for a two-year term beginning on the date this Order is issued. GDF SUEZ is a Delaware limited liability company with its principal place of business in Charlestown, Massachusetts.

#### II. FINDING

The application has been evaluated to determine if the proposed import and/or export arrangement meets the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under section 3(c), the import and export of natural gas, including LNG, from and to a nation with which there is in effect a free trade agreement requiring national treatment for trade in natural gas and the import of LNG from other international sources are deemed to be consistent with the public interest and applications for such imports or exports must be granted without modification or delay. The authorization sought by GDF SUEZ to import LNG from Canada by truck meets the section 3(c) criterion and, therefore, is consistent with the public interest. This Order authorizes transactions with terms of no longer than two years.

### ORDER

Pursuant to section 3 of the NGA, it is ordered that:

- A. GDF SUEZ is authorized to import LNG up to the equivalent of 1 Bcf of natural gas from Canada by truck, pursuant to transactions that have terms of no longer than two years.

  This authorization shall be effective for a two-year term beginning on May 23, 2013, and extending through May 22, 2015.
- B. This LNG may be imported by truck to any LNG receiving facility in the United States and its territories. This LNG may be imported by truck at any point on the border between the United States and Canada.
- C. Monthly Reports: With respect to the imports of LNG authorized by this Order, GDF SUEZ shall file with the Office of Natural Gas Regulatory Activities, within 30 days following the last day of each calendar month, a report indicating whether imports of LNG have been made. Monthly reports shall be filed whether or not initial deliveries have begun. If imports have not occurred, a report of "no activity" for that month must be filed.

If imports of LNG by truck have occurred, the report must give the following details of each LNG cargo: (1) the name of the U.S. receiving facility; (2) the country of origin; (3) the point(s) of entry; (4) the name(s) of the supplier(s)/seller(s); (5) the name(s) of the LNG transporter(s); (6) the volume in Mcf; (7) the price per MMBtu at the point of entry; (8) the duration of the supply agreement; and (9) the geographic market(s) served (list State(s), U.S. Census Region(s), or general U.S. geographic area(s)).

D. The first monthly report required by this Order is due not later than June 30, 2012, and should cover the reporting period from May 23, 2013, through May 31, 2013.
