Whereas the exports of liquefied natural gas (LNG) to global markets will create a demand for increased production in the United States; and

Whereas increased production of LNG will create a demand for thousands of new jobs throughout the United States and especially in Arkansas and other states whose economies have historically relied strongly on production of oil and natural gas; and

Arkansas is the eighth largest producer of natural gas in the United States and therefore would benefit directly and indirectly from increased production, directly through job growth and tax revenue in isolated rural regions where production tends to occur, and indirectly through heightened business activity in communities where production takes place because of increased demand for equipment purchases, support services, groceries, hotel rooms, amenities and other economic activity resulting from workers moving into the area; and

Whereas in like fashion the regional economies of states neighboring Arkansas also will benefit from LNG exports because Texas, Louisiana, and Oklahoma are the first, second, and fourth largest producers of natural gas; and

Whereas exporting LNG to global markets will increase Gross Domestic Product, thus strengthening the entire U.S. economy; and

The exports of LNG will improve business and diplomatic relations with the foreign trade partners of the United States, for example by helping close allies like Japan cope with serious energy challenges; and

Whereas the environmental benefits of increased use of natural gas deserve particular emphasis, considering that the federal Energy Information Administration recently determined that the use of natural gas as an energy source would help the United States reach the goal of reducing greenhouse gas (GHG) emissions to 1992 levels; and

Whereas by exporting LNG to global markets, the United States will provide a source of cleaner energy to emerging nations whose industrial base is growing, thereby helping them reduce their global GHG emissions; and

Whereas the Arkansas Legislative Oil and Natural Gas Caucus, whose members represent all four of the state's Congressional Districts, and of whom 29 members voted unanimously in support of increasing LNG exports, hereby recommends that the Department of Energy adopt such regulations and policies that would best and most efficiently promote the production and export of liquefied natural gas (LNG) from domestic sources to the global trading partners of the United States.
